



Regulations for the Rencontre Bodypainting France 2026

For all participants:

1. The Rencontre Bodypainting France is organised by the artistic group "Les Pygmalions" in Epinal, on May 29, 30, 31, and 2026.
2. Each artist is responsible for their model. It is up to them to review the following rules.
3. All participants certify that they are of legal age.
4. To participate in the event, you must complete and submit the provided form and pay the registration fee of €15 for one day or €30 for two days. Registration fees are non-refundable.
5. Image rights: By registering for the Rencontre Bodypainting France, all participants agree to be photographed and filmed. They authorize the distribution and commercial use of photographs taken throughout the event for:
 - any use for promoting the event,
 - any use to promote the author's work,
 - on any medium: exhibition, photographic print, book, various objects.Only the RBF organization and the photographer are authorized to sell the images. All participants may share them free of charge (online, social media) provided they credit the photographer and the individuals involved in the project depicted. The distribution of images or the use of media that infringe upon the dignity of individuals will not be permitted.
6. Copyright: All participants have the right to obtain and use, free of charge, the photos of the event taken by registered individuals for the full legal term of

copyright protection and for the following uses: - All promotional activities for the individuals concerned, regardless of the medium: press, postcards, printed materials, websites, public screenings, competitions, etc. - All public exhibitions (galleries, regardless of status or access). The photographers authorize the RBF organization, for the same duration, to sell these photos in order to finance the event and its future editions.

7. Participants agree to mention the names of other collaborators (artist, photographer, model, hairdresser) in publications.
8. All participants certify that they will not publish the photos on a website/page that could give other participants a bad reputation. (Ex: erotic websites, etc.)
9. Each participant (models, artists, and hairdressers alike) has the right to request the removal of a published photo if they find it embarrassing, vulgar, or representative of the group. If the person who posted the photo objects, the artistic group Les Pygmalions will make the final decision.
10. Participants hereby waive any compensation or remuneration of any kind whatsoever for the reproduction or distribution of images.
11. The Les Pygmalions group reserves the right to use photos of the event in the context of publications on social networks, on the website and on sites specializing in bodypainting, as well as printing on posters, brochures, banners and other communication media to advertise the meeting for the following years.
12. All models are required to wear at least a thong or a loincloth.
13. One model per artist: During the execution of individual projects, for organizational reasons it is forbidden to paint two models or for one model to be painted by two artists.
14. Only makeup products designed exclusively for body painting are permitted. We ask that you consider the safety of your model. However, the Bodypainting France Meeting is in no way responsible for the makeup products and equipment used by participants during the event. In the event of an incident related to the products, such as an allergic reaction or any other problem, the artist or user of the product in question will be solely responsible.

15. Each participant will be responsible for the equipment entrusted to them during the event. For any damage, the person will be required to repair or pay for the repairs.
16. No participant who has been known to have been the subject of inappropriate behavior towards another participant in or outside of RBF will be admitted.
17. Delivery. Participating photographers agree to provide their photos to the organization and its artist/model before July 30th. The files will be uploaded to the space of Online storage provided by the organization. Photos will be provided with a Maximum size per photo: 1 MB. The RBF logo will be affixed to each photo, along with the photographer's name if they so wish, in a corner of the image. The photographer will provide it on request, on a case-by-case basis. High-definition version without logo when the organization requests it to print copies.
18. In case of non-compliance with these rules, the organization reserves the right to refuse the participant's participation in the next edition of the event.
